There were 1,565 artists served by these programs in FY13.

4b (Code:) (Expenses \$ 144,796. including grants of \$ 127,500.) (Revenue \$) Fellowships award \$7,500 to practicing professional artists of exceptional talent and demonstrated ability. The Fellowship is a merit based, not a project based award. Recipients are selected through an open, competitive panel process. There were 17 Fellowship recipients in FY13.

4c (Code:) (Expenses \$ 110,937. including grants of \$ 90,660.) (Revenue \$) Grants for Artist Projects (GAP) provide support for artist-generated projects which include (but are not limited to) the development, completion or presentation of new work. Recipients are selected through an open, competitive panel process. There were 62 GAP recipients in FY13.
